

SME Equity Fund Ltd ("SEF" or "The Fund") is a private equity fund licensed by the Financial Services Commission as a Professional Collective Investment Scheme. Its main objective is to provide equity and quasi-equity financing to Mauritian companies. SEF is managed by Capital Asset Management Ltd, a wholly-owned subsidiary of the State Investment Corporation Ltd.

Qualification requisites

The Business Introducer application is open to professionals including corporate organisations. Professionals should be members of a recognised professional body whereas corporates should be licensed by a regulatory body such as the Financial Services Commission or the Financial Reporting Council. Eligible interested professionals may be from the following fields (non-exhaustive):

- . Accountants
- . Business Consultants
- . Legal Professionals
- . Engineers

SEF may also consider its existing and former clients who do not meet the above criteria as Business Introducers.

Main responsibilities

The main responsibilities of the BI would be to connect companies having viable businesses and growth prospects, as well as start-ups that require equity/quasi-equity finance to SEF. The latter will apply its normal due diligence process to each company referred by the BI and will take its decision. Fees

A success fee of 0.5% of the amount disbursed, capped to Rs15,000/- per project will be paid to the BI upon successful disbursement.

Since the enlistment of BI will be an on-going exercise, application received after 31 January 2020 will be considered for subsequent batches.
